Enrollment Policies

Payment: We accept Visa, MasterCard & Discover, as well as checks or money orders made out to “Wonders”, or cash in person only. There will be a \$20 fee for returned checks. Installments may only be made by credit card. If you are paying by installment, 1st is due with enrollment for fall only or 1st and 10th are due with enrollment for full year.

Discounts: If you are paying in installments, any discounts will be broken down to apply equally to 2nd – final installments.

Installments: 1st due with enrollment; then due at start of 4th, 8th, etc. week of classes: 9/28, 10/26, 11/29, 1/10, 2/7, 3/14, 4/11, 5/20.

Enrollment Discounts: We have a variety of multiple-class and multiple-sibling discounts. Please see our website for more information.

Referral Discounts: For every new family that lists your family as a referral, you will receive a \$25 class credit towards a future class. Referral credits may not be used towards enrollment in the current semester or season.

Re-Enrollment Discounts: All re-enrollments made by the date sent via email or on signs at Wonders receive a discount.

Withdrawals/Refunds: If you withdraw your child, you will receive class credit towards a future class minus any classes taken, or you may request a tuition refund minus a 10% fee and any classes taken. Refund requests must be made in writing. Refunds may take up to 4 weeks. No refunds are given for events that are out of our control (flood, fire, electrical outage, etc).

Absences/Make-Ups: A child may make up 1 missed class per session at either the Carmel Valley Annex or the Encinitas Center, during the same session, IF SPACE ALLOWS. No refunds or class credits will be given for missed classes. Make-ups must be arranged with the Director prior to showing up.

Holiday Closures: Wonders will post or email all holiday closures. It is your responsibility to be aware of such dates. Our calendar is at: www.wonderslanguage.com/classes#calendar. Installments will not be adjusted, as that is accounted for within each installment.

Substitutions and Cancellations: Wonders reserves the right to provide a substitute teacher if the regularly scheduled teacher is unable to teach classes. If we must cancel a class, children may attend an existing class during the same session at either the Carmel Valley Annex or the Encinitas Center IF SPACE ALLOWS. If space does not allow, or you prefer a refund, you may request a class refund for all cancellations excluding for events out of our control (flood, fire, electrical outage, etc). Refund requests must be made in writing. Refunds may take up to 4 weeks.

Program Policies

Ages: Children must be within the age range specified, as of the first day of class.

Adult Participation: One adult per child must attend all Toddler classes and must participate fully, either silently or using the foreign language if known. (No other languages please!) In all other classes one adult may observe silently on the first day for the first 20 min.

Pick-Ups: Wonders is not responsible for children who arrive more than 5 minutes before the scheduled class time nor for children who remain 5 minutes after the scheduled class time.

Hacienda Building: Our building has a number of professional offices. Please do not allow your children to run or shout in the shared garden area. You are welcome to wait in our waiting room if you arrive early.

Health: Children must be healthy on the day of class and free of fever for 24 hours prior to class.

Snacks: No food is provided or shared. Feel free to provide a bottle of water (no juice please).

Information Changes: It is your responsibility to inform Wonders of changes to address, phone, or emergency contact info.

Medical Emergency: You give permission to Wonders, LLC and its owners and operators to seek medical treatment for the student in the event they are not able to reach you or the emergency contact(s) provided. You hereby declare any physical/mental problems, restrictions, or condition and/or declare the student to be in good physical and mental health.

Injuries: You waive the right to any legal action for any injury sustained on Wonders property resulting from normal activity or any other activity conducted by the students before, during, or after class time.

Release of Liability: You release and hold harmless Wonders, LLC and its owners and operators from any and all liability, claims, demands, and causes of action whatsoever, arising out of or related to any loss, damage, or injury, including death, that may be sustained by the participant and/or the undersigned, while in or upon the premises or any premises under the control and supervision of Wonders, LLC and its owners and operators or in route to or from any of said premises.

Photo and Video: Your child may be photographed or videoed at Wonders. These photographs and videos shall be owned by Wonders and may appear in Wonders promotional materials. Permission is granted for Wonders to copyright such photographs and videos in its name. No child whose photograph or video is used will be identified by name, nor will any compensation be extended for such use.
